#### **Director's Report**

The bookmobile is tentatively fixed again. There isn't any water as of yet and it has rained a couple of times.

The friend's have agreed to purchase new shelves for the kid's area that are mobile. I am waiting on a quote from Demco. The amount they set aside will not be enough for all the shelves. They have agreed to \$12,000. The shelves are roughly \$1300 to 1900 a piece. The good news is that the ISD recently received a grant that's going to help the schools, our library and Spies. I don't know the exact amount they will receive and consequently, what we have available. They said to think big and create a wish list. The shelves would be the top. Because the friend's are contributing already I feel like this is a good opportunity to complete the project.

The second item on the list would be an Obie, which is an interactive projector that

casts onto the wall, floor, and/or table. This would be \$7520 for the device, installation, all the games (350), and 5 years of maintenance.

Third would be carpet for the kids area. Macco's was here today for an estimate. We had a pumpkin carving party here on the 27<sup>th</sup>. It was very well attended! The friends agreed to purchase up to 50 pumpkins and Maki's gave us a deal on \$2 per pumpkin, we had all 50 pumpkins signed up for and 4 others who brought their own, plus other littles who came to play.

We had trick or treating here on Halloween with 84 kids and 36 adults.

<u>Commissioner's Report:</u> Commissioners had mostly been taking about the lack of affordable housing. They talked about the hotel going up where K-Mart was.
